Community Case Management requires training, set up, monitoring, and reports and therefore requires requesting additional fees or donations to sustain the system. The following fee-for-service schedule will take effect January 1, 2009 and will be good until December 31, 2009.

1. Basic Case Management [On-Line Support Assistant (OLSA)] - \$750.00/yr per agency. This is licensing fee only.
2. We ask that faith based organizations providing services with all volunteer staff to donate \$75 -\$200 a year to help sustain 4People Resources and Case Management system.

I & R services have been provided at no cost to agencies and organizations whose services are profiled. The case management database has been provided for a small fee to help offset the cost of the annual VisionLink Tapestry license fee. Many hundreds of hours of technical and other professional support have been provided in support of the case management system at no additional cost. 4People has been operating at a loss with no paid employees the entire time.
